Councillors Aleisha Rutherford and Susan Baty declared a conflict of interest in Item 6 - Summary of the Sale and Supply of Alcohol (Harm Minimisation) Amendment Bill (clause 11) and item 7 - Presentation Health Coalition Aotearoa (clause 12) and took no part in discussion or debate.

Ms Danielle Harris declared a conflict of interest in Item 9 - Recommendation to engage Sector Lead organisations (clause 14) and took no part in discussion or debate.



2-22 Public Comment

Councillor Aleisha Rutherford entered the meeting at 1.30 pm.

Kerry Hocquard from the Cancer Society made public comment on three legislation reforms: the Smokefree 2025 Action Plan, the Vaping Remit proposed by Kaipara District Council for LGNZ/AGM, and Dr Nicki Jackson's advocacy to reduce alcohol-related harm.

She spoke on the Smokefree 2025 Action Plan launched last year – already endorsed by PNCC – and its importance to address tobaccorelated harm and create Smokefree environments. She also pledged to the Councillors to write a submission on Smokefree Environment/Regulated Products Bill when the submissions will be called for at the end of July.

Regarding the vaping products, Kerry Hocquard asked for the Councillors' support for the Kaipara District Council Remit proposed for this year's Local Government New Zealand Annual General Meeting addressing the growing number of retailers selling vaping products. The Remit requests the Government to restrict the sale of vaping products to R18 specialist vape stores and to develop proximity limits to prevent the clustering of vaping product retailers.

Lastly, Kerry Hocquard, on behalf of the Cancer Society, declared their support for Dr Nicki Jackson's request that the Councillors publicly endorse Chlöe Swarbrick's Bill addressing alcohol-related harm.

According to her, alcohol is readily available, affordable, and widely promoted in the media; it's in our neighbourhoods, particularly in the low-income areas, yet it is a class1 carcinogen and a known cause of cancer. The Bill addresses alcohol availability, affordability and marketing by promoting ways to reduce consumption and alcohol-related harm equitably.

3-22 Presentation - Manawatū Multicultural Council

Nina Kirschbaum, President of the Manawatū Multicultural Council, and Febry Suharto, Committee member, spoke on the Manawatū Multicultural Council's activities for the last 2 years which included:

- a Community Connection Project to provide connections and direct support to access information and services in the community.
- a Navigation Project to support ethnic communities to understand and respond to Covid-19 effects.
- a Welcoming School Project to help students, parents and schools in Palmerston North to create culturally inclusive and welcoming schools.

Nina Kirschbaum also presented the Manawatū Multicultural Council's plans for a Multicultural Community Hub with a community hall and kitchen, classrooms, cultural areas, multicultural play area, etc. to accommodate multiple activities and services the Manawatū Multicultural Council offers.

Febry Suharto presented an analysis to support the activities of the Manawatū Multicultural Council mentioning its:

- strengths include 58 diverse ethnic groups as members and a strong partnership with the PNCC and other government agencies.
- opportunities such as the Hub which would address the needs of a diverse ethnic community, branding and positioning Palmy as a welcoming city, attracting talent and economic development, etc.
- weaknesses such as limited funding and inclusive spaces;
- threats such as the increased expectations from the ethnic groups and the lack of sustainable funding.

5-22 Presentation - Health Coalition Aotegraa

Dr Nicki Jackson, Executive Director of Alcohol Healthwatch, spoke regarding the importance of the Sale and Supply of Alcohol (Harm Minimisation) Amendment Bill for New Zealanders.

She presented 2017-2020 statistics from the MidCentral District Health Board on alcohol use to illustrate the hazardous use of alcohol in our region, similar to the national numbers, especially among the people in the most deprived populations. The harm to the drinkers and others listed by Dr Jackson included violence and crime, road deaths and other injuries, family harm, poor mental health issues, cancer, heart disease, strokes, and Foetal Alcohol Spectrum Disorder (FASD).

According to her, the biggest drivers of alcohol use and harm in New Zealand nowadays are increased affordability, ubiquitous and uniquely targeted advertising, and high availability.

Dr Jackson explained the key points of the Private Member's Bill she is seeking support for, including being in pursuit of positively and permanently changing our drinking environment; restricting the availability of alcohol by removing appeals from the District Licensing Committee's decisions and strengthening criteria for licence applications; also ending alcohol sponsorship at broadcast sport.

Regarding the Local Alcohol Policy (LAP), she vowed to go back to what was promised to the community in 2012, to improve community input into local alcohol licensing decisions. At the moment, LAP's in Aotearoa only affect 34% of the population, with city councils such as Wellington City Council, Auckland City Council and others giving up after long Court battles and other issues that prevented the adoption of their LAP's. Nevertheless, she noted the overwhelming support for



change from the community, e.g. the 95% support for the Local Government NZ Remit 2018.

Regarding alcohol sports sponsorship, Dr Jackson presented data to support the need for change just like what was done for tobacco sponsorship in 1995, because to normalise and glorify alcohol use isn't just about brand awareness or switching; it impacts overall attitudes toward alcohol.

Finally, Dr Jackson recommended the PN City Council follow other Local Government Units and MPs by supporting the Private Member's Bill and calling for a review of the national liquor laws, demanding a broad review that addresses price, availability and marketing of alcohol.
