### **172-23 Presentation - Students Against Cuts**

Joshua Parsons and Matt Russell, Massey University students and members of Students Against Cuts, presented their concerns about the proposals at Massey University and their impact on the students and broader community.

The presenters stated that:

- The cuts undertaken by Massey University were the largest in the tertiary sector. Massey's capacity for science, teaching and research had diminished significantly.

- Students protests were organised in response to a lack of transparency and proper engagement with affected parties.

- Students Against Cuts was seeking a pause in the restructure process and the return of funding to the tertiary education sector; as well as access to Massey University financial information. They requested a meeting between the Ministry of Education/Tertiary Education Commission, University Management, community stakeholders such as the Council, business and community organisations of Palmerston North, and students and staff.

- Students Against Cuts requested support from Council to build back better aiming for a university that is really tight in the city, including the following specific requests:

- (i) appeal to the Tertiary Education Commission and University Council, on behalf of Palmerston North;

- (ii) support a Palmy 'Save Massey' Hui with venue, networks and publicity;

- (iii) make submissions on behalf of Palmerston North during Massey's consultations; and

- (iv) support their call for a broader and more inclusive approach with discussions involving all stakeholders.
