- In Table 12, change the Growing out score for 'A city with minimal



environmental impact' from 2 to 0, and make the corresponding change to Table 9, along with change in the narrative in Table 9 to better reflect that urban sprawl does not have a positive environmental effect.

- In Table 12, change the Balanced growth score for 'A city with minimal environmental impact' from 2 to 1, and make the corresponding change to Table 11.
- In Table 12, change the Growing up score for 'A city that embodies Te Trite partnership' from -1 to 2, and make the corresponding change to Table 8, along with change in the narrative in Table 8 to better reflect that if stormwater concerns are addressed the Te Tiriti partnership impacts will not be negative.
- In Table 12, change the Growing up score for 'A city that prioritises the Maori and health of waterbodies and connections to them' from -1 to 1, and make the corresponding change to Table 8, along with change in the narrative in Table 8 to better reflect that if stormwater concerns are addressed the environmental impacts will not be negative.
