The Tenants Union would like to see landlords meet their legal obligations before the law takes effect, as in the interim tenants are living in unhealthy homes.

Cameron highlighted that all of Council's social housing stock complied with the Healthy Homes Standards.

Manawatū Tenants Union requested Council's endorsement of the Healthy Homes Commitment – to encourage landlords to meet the healthy home standards earlier than legally required.
